The VCC Emergencies Ministry continues to support flood affected individuals and communities across the Moira Shire.

Cars have been hired (pictured) to support volunteers with their work. Four teams in cars have spread their support, care and compassion across the shire from Barmah in the west to Wilby in the east, Cobram in the north and Katandra in the south.

Debbie Lapthorne (Vol. Operations Coordinator) and her dedicated teams of volunteer co-ordinators and workers have undertaken a massive task to make sure as many people as possible have had access to information and support during this time.

In the past two months, the VCC EM has been very busy developing structures, processes and policies which will support the ever changing operational requirements in the future.

Debbie Lapthorne - Operations Coordinator states "The way in which we approach our deployment is certainly different to our approach three years ago. We continue to earn our place at the table with the larger organisations - our input in not only valued but requested, and our presence is now expected rather than questioned. That is not to say that the work undertaken in years gone by was any lesser quality, it has always been an excellent service, from people whose hearts are to serve, love and support.... but the processes, policies and procedures which are now in place have shown the emergency management agencies, and state and local governments of the necessary program development in response to the changing arrangements in Victoria."

We need to increase the number of stand alone Incident Activity Coordinators, who are there to either support current structures or act independently at an event."

Training & Development

The 2012 Training Schedule has been released.

As we complete nearly five months of Personal Support deployment to the Hume Region floods we celebrate effective support of 4306 affected people with 477 volunteer days in relief and recovery centres and visits to 2038 homes! During this time also we have responded in Gippsland floods, at the Melbourne Airport (twice), and in a number of smaller events.

The statistic that is not documented is the crucial contribution by various and countess **Coordinators** – Area and Regional Coordinators, Incident/Activity Coordinators and a new Operation Coordinator role – all volunteers delivering remarkable 'behind the scenes' service. Without this service the truly impressive statistics above could never have happened.

We are fortunate indeed that **Coordinator Training** had commenced prior to the Hume floods. This event has highlighted just how important this training is!

The one day **Coordinator Training Module B** is scheduled for Wed 8th August in Mirboo North, and Mon 20th August in Wangaratta. This Module prepares Coordinators for deployment tasks.

Module A has been designed and will be presented to all attending the Coordinators

Further Reflection:

A feature of most training events during 2012 has been to remarkable richness that comes as we embrace cultural and faith diversity. Most Level 1 and Level 2 training this year has included personal support volunteers and chaplains from diverse language groups, cultures and faiths.

The value of this wider inclusion was comprehensively demonstrated in the HOBEX exercise where Karen, Vietnamese and Chinese speaking VCC EM personnel were highly valued by partner organisations and by the affected people themselves. Imagine trying to register your presence at a Relief Centre where nobody speaks your language!

As it is for language so it is for cultural connection, and for faith-based spiritual support. We do our best work when we can speak the 'language' of the affected person.

I am encouraged that in all cases the training was richer for the presence of these diverse backgrounds. The move into multifaith training is in fact seamless apart from this sense of greater depth through wider inclusion.

Multi-faith Project

We continue our exciting journey as a multifaith and multicultural program.

In the beginning of July we held training at Quang Minh Buddhist Temple in Braybrook in Melbourne's western suburbs. We had thirty-five new volunteers attend. There were twenty Vietnamese Buddhists and one Vietnamese Catholic nominated by the temple itself, including the abbot Thich Phuoc Tan OAM. Four Laotian Buddhist monks, ten Anglo-Australian Buddhists and a Christian minister also participated.

Two weeks later we were involved in HOBEX. Three Karen-speaking volunteers, a Vietnamese-speaking personal support worker, and a Buddhist chaplain who speaks Malay, Cantonese, Mandarin, and Hokkien, were involved. Many of

the "affected people" in HOBEX did not speak English and the presence of our multilingual volunteers was absolutely crucial.

The latest census figures show the increasing religious and cultural diversity in Victoria. For example, the number of Punjabi speakers has grown by 207%. Hinduism is now the fastest growing religion in Victoria. To have the capacity to serve the Victorian community in times of crisis, our volunteers need to reflect this cultural and religious diversity. We are working in partnership with Buddhist, Hindu, Muslim and Sikh communities to train volunteers who can serve not only their communities, but the wider community too. In the coming months we will hold more training sessions in Buddhist,

Hindu and Sikh temples and Muslim mosques.


New research is emerging related to the benefits of providing an holistic broad based psycho-spiritual care framework for disaster trauma affected individuals and communities

Mazlow's Heirarchy of Needs - a new paradigm! Cont.

We continue to look at the new developments and understandings from Mazlow's Heirarchy of Needs and the implications for emergency management arrangements in Victoria.

As previously discussed, Abraham Mazlow developed his theory from a predominantly individualist cultural paradigm. He continued to develop his theory in the 1960's to include a sixth stage - Transcendence - which would address his growing understanding of the importance of spirituality in how people function in society.

I spoke in the last newsletter of the limitations of Mazlow's 5 stage hierarchy when applied across cultural difference, particularly in a collectivist society where 'belonging' is central to social functioning.



We now understand that Esteem Needs which appear on Mazlow's Hierarchy as the fourth stage is problematic in that human developmental theory would suggest that

self esteem is something which is imperative I have heard it said in emergency in the early stages of development. I have heard it said in emergency in the early stages of development.

I propose that another way to understand human development in the context of trauma recovery, taking on board Mazlow's 6 stages could look like this:



The notion of belonging becomes central to human need, from which all other aspects of life, as outlined in Mazlow's theory can be obtained.

This model allows for a more flexible approach to recovery development. People can have their needs met individually, simultaneously, and are able to move backward and forward, which is a significant limitation to Mazlow's hierarchy. Mazlow indicated that people would progress through the stages depending on how their needs in a preceding stage were fulfilled. This adapted model takes away the constraints of time, hierarchy and rigidity.

Currently, emergency managers in local government and state government agencies like the Department of Human Services use, as part of policy and practice development, Mazlow's Heirarchy of Needs - as we understood it to be and as it has been historically published and taught.

It makes sense from this understanding that as long as the basic physical needs are met, people's recovery trajectory will be positive. However, this is not our experience. It is often observed that despite providing 'soup, soap and shelter' to affected individuals, their emotional and social needs continue to manifest.

I have heard it said in emergency management meetings that 'we don't want people to become too comfortable at the relief centre, so we purposefully provide only enough physical support for the short term, as we want to get them out of there'. This kind of statement does not take into account the long term costs of the absence of or inadequate provision of psychosocial support.

Individuals who present to a relief centre do so as a fully formed human being, not a compartmentalized person. In their fully formed state, they require safety, containment and predictability. Affected people will need shelter, food, water and information. But this alone is not enough to support a positive psychosocial recovery trajectory.

Human need and development dictates that affected people also need belonging. Belonging involves all aspects of Mazlow's original hierarchy of need with the addition of self transcendence. Belonging is a form of connectedness and this connectedness supports positive psychosocial recovery. If i am positively connected and belong to self, others, or a larger paradigm of something/ someone beyond myself, I have a better chance of achieving all other needs.

Connection is more than the provision of shelter, food,water and information. It is the meaningful human interaction with a non affected person in the provision of compassion, comfort, care with dignity and hope. This is inclusive of emotional spiritual care and seeks not to compartmentalize human need but sees the person as a whole and complete being whose needs are intertwined in the event. It seeks to support the recovery trajectory through the integration of the event by providing a safe place to talk about the experience.

It's only when an affected person can find the language for the experience that true recovery can occur.
